# Streamlining Data Upload to Gain New Process Efficiencies with Corptax Data Exchange

### Excessive Manual Upload of Tax Data

Kimberly-Clark needed a more efficient way to load data into their system. They were struggling under a process that required an excessive number of files to be manually uploaded, draining their time and resources. For each entity, six files were required. For every trial balance data file, they had to upload twice—once in local currency and once in U.S. dollars.

Intercompany data and book-to-tax adjustments were the same story. More than 200 entities meant loading over 1,200 files manually, taking two minutes each—on top of the time it took to create the files.

Initially, Kimberly-Clark tried a process of concentrating six files into one with enhanced mapping. While this reduced manual work, it limited flexibility. For example, if one part of a large file were wrong, they had to re-map and start over. They wanted a system that offered speed and efficiency.

### Automation, Consistency, and Flexibility
